This is in continuation to University's Notification No. GGSIPU/Academics/2017/20784 dated 26/05/2017.

**A. '50% GGSIPU Quota Seats in MD/MS/Diploma' Seats**

- (i) **'Registration for Counselling and Verification of Documents'**  
(Only in case of the candidates who applied earlier but could not register for counselling on 14/04/2017 and for the candidates who applied afresh consequent to the University's notification No. GGSIPU/Academics/2017/20784 dated 26/05/2017).
- (a) All the candidates (as explained in the above para) who have passed MBBS from the affiliated medical colleges of Guru Gobind Singh Indraprastha University and must have completed one year compulsory rotatory internship on or before 30<sup>th</sup> April 2017 and also qualified NEET PG 2017 are eligible for 'Registration for Counselling and Verification of Documents'.

(b) All the NEET qualified candidates will present themselves for 'Registration for Counselling and Verification of Documents', in person, on the scheduled date and time, as given below.

(c) The candidates who were registered before the start of 1<sup>st</sup> Round of Counselling, on 14/04/2017 participated in the 1<sup>st</sup> and 2<sup>nd</sup> Round of Counselling. The University re-invited the online applications consequent to the Revised 'Percentile' and Revised 'Cut Off Score' as per the Notification No. GGSIPU/Academics/2017/ 20784 dated 26/05/2017. Thus, these newly applied candidates and the candidates applied earlier could not register for counselling, shall present themselves for 'Registration for Counselling and Verification of Documents'.



**All the admissions are provisional. The candidates shall undergo biometric verification to be carried at the respective allotted medical colleges.**


C. **Hamdard Institute of Medical Sciences and Research (HIMSR) Jamia Hamdard**


